- 2.6 All postal ballot forms received upto the close of working hours on 16th April, 2011 being the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- 2.7 Envelopes containing postal ballot forms received after 16th April, 2011 were not considered for my scrutiny. Such envelops aggregate to 9 vide serial number 1 to 9. These envelopes were not opened and they are separately kept.
- 2.8 Envelopes Containing postal ballot forms returned undelivered aggregated to 836 (eight hundred thirty six) vide serial number 1 to 836. These envelopes were also not opened and they are separately kept.
