Further, the Company has been operating since 1936 and one of the Promoters of the Company, being Foreign Body Corporate, holds 25.1% equity share capital of the Company, in terms of relevant permissions obtained, prior to the said prohibition in FDI coming into place. ii. Foreign Portfolio Investment (FPI): 24.00% - As per the Rules, the aggregate limit is 24%. iii. Non-Resident Indian (NRI) or Overseas Citizen of India (OCI) on repatriation basis: 10.00% - As per the Rules, the total holdings of all NRIs and OCIs, put together, shall not exceed 10% of the total paid up equity capital. The aggregate ceiling may be raised to 24% if special resolution is passed. Please note that the Company has not passed any special resolution, hence the limits continue to be 10%.
