Pursuant to the provisions of Regulation 30 of the SEBI Listing Regulations, we wish to inform you that at the 88th Annual General Meeting (AGM) of the Company held today i.e. on 4th September 2025, the Shareholders have, *inter-alia*, approved, the following:

- 1) Re-appointment of Mr. Sumant Bharadwaj (DIN:08970744) as an Independent Director of the Company, for the second term of five consecutive years i.e. w.e.f. 13th February 2026 up to 12th February 2031. The details as required under Regulation 30 of the SEBI Listing Regulations read with the SEBI Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November 2024, as amended by the SEBI Circular dated 31st December 2024 ('SEBI Circular'), are enclosed herewith as **Annexure-A.**
- 2) Appointment of M/s Chandrasekaran Associates, Practicing Company Secretaries, New Delhi, as the Secretarial Auditors of the Company, to conduct Secretarial Audit for Five (5) consecutive years i.e. w.e.f. FY 2025-26 to FY 2029-30. The details as required under Regulation 30 of the SEBI Listing Regulations read with the SEBI Circular are enclosed herewith as **Annexure-B**.
- **3)** Increase in the Authorised Share Capital of the Company and consequent alteration in the Clause on Capital in the Memorandum of Association of the Company by substituting the existing Capital Clause (Clause 5) with the following Clause:

"The Authorised Share Capital of the Company is Rs. 50,00,00,000/- (Rupees Fifty Crore) divided into 24,70,00,000 (Twenty-Four Crore Seventy Lakh) Equity Shares of Rs. 2/- (Rupees Two) each and 60,000 (Sixty Thousand) Preference Shares of Rs. 100/- (Rupees One Hundred) each with rights, privileges and conditions attaching thereto as are provided by the regulations of the Company for the time being, with power to increase and reduce the Capital of the Company and to divide the shares in the capital for the time being into several classes and to attach thereto respectively such preferential, deferred, qualified or special rights, privileges or conditions as may be determined by or in accordance with the regulations of the Company and to vary, modify or abrogate any such rights, privileges or conditions in such manner as may for the time being be provided by the regulations of the Company."
